



## Revised Bus Service Modification Index

### General Information

The development of the FY11 Service Plan was guided by several principles that:

- Sustained a maximum level of ridership
- Maintained connections to major activity centers and critical “lifeline” facilities
- Complied with federal mandates
- Developed a core service that is reliable and sustainable

After extensive public comment, subsequent analyses, and evolving sustainability considerations, staff is in the process of developing service alternatives that introduce flexibility in plan development given various funding scenarios. These alternatives increase the level of service relative to the “Reduced Plan” provided that funding is available.

Community forums provided the Planning staff with an opportunity to interact with customers directly and receive specific comments related to the impact of the proposed service reductions on their commute. These comments were reviewed by route to determine if and how the concerns and impacts would be addressed as the plan is finalized. Primary themes from the public served as additional criteria for refinement and focused on:

- Significant disconnects from jobs, community facilities, and points of necessity
- Increased walking distance for transit-dependent Senior areas
- Notable omissions impacting persons with disabilities
- Excessive travel time increases due to indirect routing
- Neighborhood/community connections to rail stations

The prioritization of specific bus services to be added to the plan will allow MARTA to best determine how to sequence the growth of the system above and beyond the plan currently under development.

### Index Key

#### Index Organization

Almost all MARTA bus routes have been impacted by these proposed modifications. As a result of public input, a number of originally-proposed changes have been modified. This index groups bus routes by the type of change we are proposing, detailed below:

	<b>No Change</b> - No modifications to these routes are proposed.
	<b>Original Modification</b> - We recommend implementing modifications to these routes as they were originally proposed.
	<b>Refined Modification</b> - We have refined our proposed modifications to these routes due to public input.
	<b>Route Eliminated</b> - These routes are proposed for elimination. However, parts (or segments) of these routes may still be served by other routes in the plan.

We have provided the following information to explain the route modifications as applicable:

- **Route** - the route number as currently operated.
- **Name** - the route name as currently operated.
- **Proposed Modification/Original Proposed Modification** - the original proposed modification that was presented to the public.
- **Recommendation/Refined Modification** - our refined modification, designed to address comments and concerns from the community
- **Rationale for Discontinuation** - our rationale for recommending the elimination of any route or segments thereof.
